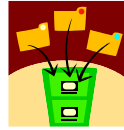

## Timeline

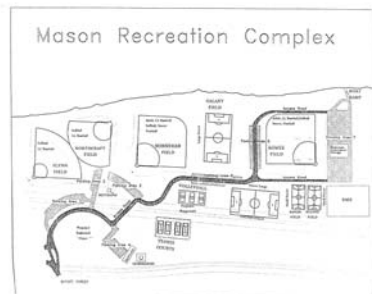
- May meeting and e-mail poll – Rec. Board approval for deactivating tennis courts.
- July 23, 2003 – preliminary meeting to establish issues and timeline for study.
- August 13, 2003 – planning meeting with skaters.
- August 27, 2003 – design meeting with skaters.
- August 4, 2004 – final design meeting
- November 2004 – Request for proposals.
- December 2004 – Open bids
- January/February 2004 – Acceptance of bid.
- March/April 2005 – Skatepark assembly
- May 2005 – Skatepark opening

## Constitution Park

- Advantages
  - Central location
  - Parking, bathrooms
  - Well used facility with multiple activity areas
  - Would add another activity for summer camp use
  - Good security
- Disadvantages
  - Site development (i.e., grading) costs
  - Much smaller site (4k-5k sq. ft)

## Mason Complex

- Advantages
  - Site (tennis courts) availability
  - Parking availability
  - Bathrooms/water fountain/concessions stand nearby
  - Adjacent action sports facilities (i.e., Canal Tow path and BMX track)
  - Accessible via Canal Tow path
  - Large site (14-20k sq. ft.)
- Disadvantages
  - Not central location
  - No adjacent shade trees

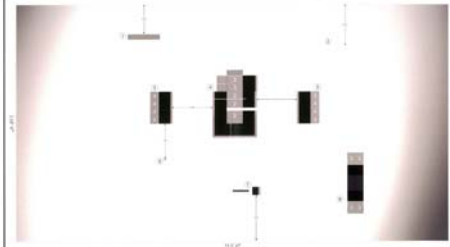

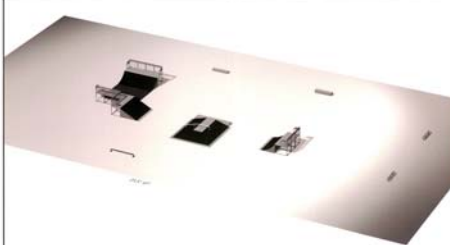

- #1 Grind box
- #2 Rails
- #3, #5 4 ft Quarter pipe
- #4 Pyramid, stairs, curb rail
- #6 Fire hydrant
- #7 Kicker ramp, grind box
- #8 3 ft half pipe
- Estimated total cost \$70,549

## Equipment

- #1, 2 Grind box
- #3 Skate bench
- #4 4 ft half pipe and 4 ft quarter pipe
- #5 Pyramid
- #6 4 ft half pipe
- #7 Grind rail
- #7 kicker ramp, 8 ft skate barrier
- #8 3 ft half pipe
- Estimated total cost \$54,528
